- 6. PLANNING/ENFORCEMENTS:
 - Kimberleys Field Cllr Rowley is to chase this up with Head of Enforcements
 - 20/0112 Watergate Barn, Neigh Lane garage conversion and rear extension, roof lights and window awaiting decision by WDC
 - Planning Reforms Cllr Rowley reported that there are two elements to the proposed changes,
 'Changes to the Planning System' with Wychavon District Council making their own representations.
 Secondly, the White Paper consultation 'Planning for the Future'. The Chairman and clerk were
 encouraged to attend the forthcoming 'virtual' review on 7th October before considering any
 response to the consultation as there could be serious implications
- 7. VILLAGE HALL Cllr King advised that the hall is now open with all risks covered. Due to the wearing of face masks within the hall, the parish council have decided to continue with Zoom meetings for the time being.
 New Pathway whilst the new pathway has been completed and paid for, the results were disappointing.
 This, along with other issues that have been raised with the contractor employed, have forced the VH committee to look for an alternative contractor. Recommendations had been received from Cllrs Smythe and Segar. Thanks were paid t both of them

Drugs – a concerned resident contacted the VH committee regarding drug activity in the car park. The police have been notified

- Overgrown Hedge, Blacksmiths Lane a report had been received regarding an overgrown hedge in Blacksmiths Lane. The clerk had written to the residents of the property and it is thought this had now been cut back. Awaiting clarification that it has been done

11. PROGRESS REPORTS:

- a) Lengthsman nothing to report
- b) New Home Bonus Holland House had advised that they did not have the time or resource to put together any sort of proposal for a possible community project, having to put all there energy into getting through the Covid crisis. A very good proposal had been received from Corran Dean with sensory activities, play area, wildlife and adventures areas. This would be a project that would be accessible and open to the whole community and not just those that attend the Care Farm. After several years of asking for suitable projects and an unsuccessful application for church toilets / servery, the parish council were in full agreement that a worthy cause should benefit from the funds available (just under £28,000). A proposal was put forward by ClIr Rowell, seconded ClIr Segar that we support Corran Dean, and subject to village consultation, an application made for the use of the NHB funds. All ClIrs were in favour
- c) <u>Community Infrastructure Levy Fund</u> In hand to be considered for traffic calming options *awaiting* input from Cllr Eyre
- d) Speeding Following a 'call to parishioners' about 10 volunteers had come forward to participate in the Community Speed Watch Scheme. We are awaiting further details. Further traffic calming options are being investigated with WCC. It was recorded that there was an accident at the junction of Field Barn Lane and the B4084 a few weeks ago
- e) <u>Bollards Lower Croft</u> The previously suggested 'grasscrete' option was considered not suitable as the whole purpose was to prevent car parking on the green. There is now a new contact at Rooftop and the clerk would make contact to discuss the damaged bollards. Parking at the back of the school is a particular problem
- f) War Memorial Nothing further to report
- g) <u>Minerals Consultation</u> Cllr Rowley reported that Tarmac had withdrawn their interest in Mineral Extraction at Charlton. We should not allow ourselves to become complacent, as whilst Tarmac are no longer interested in the site, another minerals company may come along. Good news for now. The Examination in Public will still be going ahead later in the year
- h) Passing Bay, Orchard Row the clerk has been in contact with WCC who would be writing to the owner of the offending vehicle. The clerk has chased this up with WCC. Another issue was raised regarding overgrown hedgerow. Cllr Annis reported that he had been past the property and could not see any problem

COUNTY and DISTRICT ISSUES Children and Families

- Worcestershire Children First has been working very closely with school leaders and other colleagues, including public health, to ensure that each They have worked with our schools to complete a risk assessment ahead of them reopening their doors to all pupils in September to ensure that school has an individual tailored plan for their wider reopening, based on their individual circumstances as well as looking forward to the future. their plans and all aspects of school life meet both Government guidance and the individual needs of the staff and students who work there. H
- Schools and colleges will have the discretion to require face coverings for Year 7s and above in communal areas where social distancing cannot be safely managed. 7
- A new campaign has been launched by Worcestershire Children First and Worcestershire County Council to help students and parents prepare for a safe return to school when the new term begins next month. 3
- The Return to School campaign is designed to help inform students and their carers/parents about the new measures, which are being put in place to ensure the safety of staff and students as schools reopen their doors. 4

Health and Wellbeing

- were closed for three months due to the coronavirus pandemic. The busy teams from Worcester, Bromsgrove, Kidderminster, Malvern, Evesham Births - More than 1,600 births have been registered across Worcestershire since the national lockdown restrictions eased – meaning 95% of the Register offices have been opening on some Saturdays to help to work through the large amount of registrations which developed when offices backlog has now been dealt with. Staff in Registration Services have worked round the clock to work through the backlog of birth registrations. and Redditch have now registered a total of 1,642 births since restrictions were lifted and are now left with only 80 or so births that are being processed.
- Another five libraries opened across Worcestershire on 3rd August with Droitwich, Stourport, St John's, Tenbury and Wythall opening their doors to customers for the first time since March. The remainder of the county's libraries will open during September. Since re-opening, libraries have also of Worcestershire's libraries have reopened and nearly 40,000 customers have visited those libraries since lockdown restrictions were eased. provided much needed digital access to local residents, recording over 1,500 unique computer sessions during the period 5

total for Worcestershire Libraries. Compared with July last year, last month's new Digital Memberships total was up by over 300%. The total of new month. The total number of e-issues including e-books, e-audiobooks, and e-magazines for July (17,092) was the highest ever such calendar-month The success of the Digital Library Hub is continuing to compliment the re-opening of libraries, with another fantastic set of figures for the last digital memberships for the Digital Library Hub since 23rd March (1,447) is 315.8% higher than the total for the same period last year (348).

Environment and Economy:

It has now been six months since the opening of Worcestershire's first new railway station for over 100 years (Worcestershire Parkway). The station first opened its door in February this year. 2. 5G

The Cabinet Member with Responsibility for Economy and Infrastructure is recommended

Worcestershire 5G project and the ongoing work on the West Mercia 5G project as part of the Department of Digital, Culture, Media and Sport's (DCMS) 5G (a) note the work undertaken by Worcestershire Local Enterprise Partnership (WLEP), the Council and other partners in the successful delivery of the first Testbed and Trials programme;

(b) note the successful application for funding into 'Open for Business' to support the transition of Worcestershire 5G into a sustainable model;

(c) endorse the application for two new proposed projects into DCMS's 5G Create fund;

Wave 1 and up to £4m for Wave 2 and the role of the Council as the lead partner, will be managing the projects, assuring and financing partners' claims and (d) note, should either or both of the '5G Create' applications to DCMS be successful, the award of the initial grant from DCMS would be up to £1.5m for drawing down the funding;

(e) note and accept both the potential opportunities and risks that are identified within this report and earlier 5G Cabinet reports; and

(f) authorise the Strategic Director of Economy and Infrastructure to finalise and agree the necessary agreements to progress and support the Open for Business project and the two DCMS 5G Create projects if funding applications are successful, noting that delegations in earlier 5G Cabinet reports also remain in place.

- Since Household Recycling Centres (HRCs) began to reopen in Worcestershire in May, figures show that the sites have been as busier than this time last year, despite the lockdown and social distancing restrictions. 'n
- distancing measures remained in place since reopening to protect the visiting public and staff working on the sites. A video has been shared with the same period last year. Over 14,000 tonnes of waste was delivered to the HRCs throughout the two month period since many of the sites The County Council has announced more than a 12% increase in the tonnage deposited at the recycling centres during May and June, compared on the Council's Facebook pages reminding people of how to prepare and what to expect when visiting their local Household Recycling opened in May. This is equivalent to over 800,000 black bins of waste. The figures come at a time when a number of restrictions and social Centre. 4
- On Friday 14th August the 'Make It Worcestershire' campaign to support local produce and producers launched at Bell's Farm Shop, Stourport. The campaign is aimed at celebrating local produce and will provide local producers with much-needed support following the recent restrictions due to the Coronavirus. ņ.
